### What is happening?

*Device Freeze* began on February 1 and continues until June 4, 2021. This is an important step leading up to go-live and the upcoming Technical Dress Rehearsals (TDRs). TDR allows the technical and application teams to verify all end user devices. Visit [here](#) for more information. **Please do not move any devices (e.g., workstations, printers, or scanners) during this time.**

*Training registration* will begin on February 22 and last until April 2, 2021. Managers and staff can confirm the assigned training programs by accessing ME section of Saba. From here, staff can select a live virtual class, and begin watching all of the required online videos. Live Virtual classes are scheduled from April 19– May 28, 2021. *Online Training:* Managers will have a choice to allow staff to work from home or to reserve a workstation at one of the NYP Queens Campus locations to complete the online training. Please check the [EpicTogether website](#) for upcoming information.

### What's coming up?

*Workflow Walkthroughs:* The EpicTogether team will demonstrate workflow walkthroughs for Go-Live 3 on 3/23 from 10a-12p. A livestream will be provided for employees who can schedule the time to watch from their desks. The demonstration will contain both ambulatory and inpatient workflows with the new electronic medical record.

*Go-Live Readiness Assessment (GLRA):* A global evaluation of all factors contributing to go-live for the implementation of the Epic software. This includes examination of planning, hardware, application workflows, interface readiness, end-user training, end-user adoption, operational readiness, and technical readiness. GLRAs are held at 90, 60, and 30 days prior to go-live to review the system build. The upcoming GLRAs will be held by video conference.

GLRA schedules dates:

- GLRA – 90 Day                      March 10, 2021
- GLRA – 60 Day                      April 7, 2021
- GLRA – 30 Day                      May 12, 2021
